## **INTRODUCTION**

---

The Judiciary's Automated Traffic System (ATS) is the statewide computer system utilized by all municipal courts in the state of New Jersey. ATS is the database for all traffic tickets filed in the New Jersey municipal courts.

ATS automates case management and financial procedures while facilitating the direct electronic exchange of information between the Motor Vehicle Commission (MVC) and the municipal courts. It is also available to all law enforcement agencies throughout the state of New Jersey.

ATS also serves as a management resource to standardize and automate the operations of the municipal courts while preserving local control over each court's data. The system is accessed by the municipal courts through locally operated personal computers connected by a statewide telecommunications network to the New Jersey Administrative Office of the Courts' mainframe computer. The Electronic Access Program provides real time access to municipal court traffic ticket data that is stored in the Judiciary's mainframe.

**It is emphasized that the ATS system contains municipal court caseload data and is not the repository of driver history information. Official driver histories are maintained by the Motor Vehicle Commission (MVC).**

## **OVERVIEW OF ATS INQUIRY SYSTEM**

The Automated Traffic Inquiry System was designed for non-court users who access the system from remote sites. Users will be able to view information about active and disposed tickets in ATS. The information will include violations, sentences, payments, bail and warrant information when applicable.

A list of ATS Code Tables (Appendix A) is included in this guide for reference. It gives a description of the codes used throughout the guide. For example, in a ticket, the first four digits represent the court code of the municipality the ticket was issued in. A list of all municipalities and their respective court codes is also provided (Appendix B).


## SIGNING ON AND OFF

Refer to the Superior Court of New Jersey Electronic Access Program, Court Records Inquiry System Access Guide for connecting procedures. After making the connection from your personal computer to the judiciary mainframe, the first screen that you may see prior to the log-on screen is a broadcast message.

- 1) Press the **F3** key to continue.

The next screen displayed will be the JUDICIARY TELECOMMUNICATIONS NETWORK screen (Exhibit A).

**NOTE:** The log on screens contain Help Desk telephone numbers as shown in Exhibit A. These numbers are for New Jersey Court Personnel use only. Non-court users should call the Superior Court of New Jersey Electronic Program at **(609)421-6100**.

- 2) Type **NJ** and press the **ENTER** key.

The next screen is the **INTERSESSION MANAGER** screen (Exhibit B).

### **PROCEDURES:**

- 1) Type in the USERID listed on your enrollment form and press the **TAB** key to move the cursor to the next line.
- 2) Type in your **PASSWORD**.
- 3) Press the **ENTER** key.

### **NOTE:**

- o Please DO NOT attempt to change your password on the Intersession Manager screen.
- o When an incorrect password may have been entered, please DO NOT attempt to correct. Back out of the system and then sign in again.
- o For security reasons, passwords typed on the **PASSWORD** line do not appear on your screen.

## **FIRST-TIME USERS**

If this is the first time that you are signing onto the system with a new USERID, or if this is the first time that you are signing on after your password has been reset, you must change your password as part of the log on process. The PASSWORD is the user's most important link in data security – it prevents unauthorized persons from using your ID.

The P-Synch service should be used to change your password. When changing your password, please refer to:

- The Electronic Access Program webpage
- Connecting to the Courts (Web - VPN)
- Logging in for the first time

## ***USER ID SECURITY***

If a user attempts to log on five times and is unsuccessful, the USERID will automatically be revoked. You will receive the message, “USER ACCESS REVOKED BY EXTERNAL SECURITY SYSTEM”. When this happens, call Customer Support (609-421-6100) for assistance. Customer Support will reset the password. Once reset, please refer to the Electronic Access Program webpage - Connecting to the Courts (Web - VPN) - Logging in for the first time.

Passwords will be valid for a period of ninety days, at which time the system will prompt you for a new password. You cannot reuse a password you have previously used. Passwords can also be changed at any time within the 90 day life span.

The next screen is the INTERSESSION MAIN MENU screen (Exhibit C). This screen lists the systems that are available for selection.

### PROCEDURES:

- 1) Select the number next to the description for MUNICIPAL COURT SYSTEMS (Exhibit C). This will give you access to the New Jersey Automated Traffic Inquiry System. Inquiries can be made on defendant's traffic violation information, payments, court dates etc.
  - a. The **PA1 & PA2** keys are used to scroll up and down the page.
  - b. The **Pause/Break (CLEAR)** key is used to exit the system.
  - c. Typing **LOGOFF ALL** is used to exit this screen and logoff the system.

## LOGGING OFF PROCEDURES

### PROCEDURES:

- 1) From any screen, press the **Pause/Break (CLEAR)** key to disconnect from the system.
- 2) To log off of the Judiciary computer system before you access any system, type **LOGOFF ALL** and press the **ENTER** key.
- 3) At this point you are completely disconnected from the system.

It is very important to log off as soon as you have completed your inquiry. Billing continues as long as you are connected to the Judiciary computer. Once you perform the above procedures, no further usage charges will accrue.

Upon making the connection to the mainframe, you will be on the New Jersey Map screen. If you decide not to Log On to the computer, it is important that you disconnect before walking away from your personal computer. Usage fees accumulate from the time you connect to the mainframe. Should you forget to disconnect, the Judiciary computer will disconnect you automatically after (15) minutes.

## ***DISCONNECTING***

- 1) From any screen, press the **Pause/Break (CLEAR)** key to disconnect from the system.

- or -

- 2) Click on the **X** in the upper right hand corner.

The system will respond “Do you want to close this session?”

- a. If you wish to exit, click **Yes**. The system will disconnect the session and close the window.
- b. If you wish to remain in the system, click **No**. The system will leave you signed on.

- 1) After successfully logging on, the next screen you should see is the **TRAFFIC MAIN MENU** screen shown above. If the balance in the user's account is below \$300, then access to the system will be denied and the message "**ACCESS DENIED BALANCE IS BELOW \$300**" will be displayed.
- 2) Press the **F11** key to access General Look-Ups and Inquiry. This will take you to the Ticket Inquiry Menu (Exhibit E).

### **PROCEDURES:**

- 1) Fill in the appropriate field, and press the corresponding F key to the immediate left of that field. Only one type of Inquiry can be performed at a time.
- 2) Type **A** in the Ticket Status field for viewing all tickets or an **O** for viewing outstanding tickets only. The system will default to an **O**.
- 3) Press the **PA1** key to return to the Traffic Main Menu.

### **PROCEDURES:**

- 1) Type in the ticket number, which includes the four digit court code, prefix, and the 6-digit ticket number. (Exhibit G). Please note, not all tickets have a prefix.
- 2) Press the **F1** key. This will display the Detailed Ticket Information Menu (Exhibit P).

**NOTE:** For a list of all courts and their codes, make sure the cursor is in the court code field and press the **F22** key (shift & F10) for the Help Facility or see Appendix B.

## **DEFENDANT NAME INQUIRY**

**PURPOSE:** Inquiries by defendant name. The ticket inquiry by defendant name screen will display the court date, case status, court code, ticket #, first and last name, birth date, violation code(s), and outstanding warrant.

### **PROCEDURES:**

- 1) On the second row, type Defendant's first name, and/or Middle Initial, and last name.

**NOTE:** Use the **TAB** key to move to the next field, if necessary. The First Name field has a 9 character limit, the Middle Initial field has 1 character, and the Last Name field has a 20 character limit.

- 2) When necessary, use two spaces after the last name when using generation qualifiers.  
(Ex. Jr, III)

**NOTE:** Users may inquire by a defendant's last name only. To inquire by last name, fill in the last name field only. Remember that more than one defendant can have the same name. Confirm that you have the correct defendant by verifying the address and/or date of birth.

- 3) Press the **F2** key. The system will take you to the Ticket Inquiry Display by Defendant Name screen (Exhibit I).

- 4) Type an **X** next to the appropriate defendant to display additional information. Press the **ENTER** key or the **F10** key. The Detailed Ticket Information Menu will appear (Exhibit P).

**NOTE:** After typing an **X**, pressing the **F10** key will save your current search list. The Ticket Inquiry Display by Defendant Name screen will redisplay when F10 is pressed from the Detailed Ticket Information Menu.

- 5) Press the **PA1** key to return to the Traffic Main Menu or the **PA2** key to return to the Ticket Inquiry Menu.
